Qualitative analysis of Criterion 1

Rabindrasadan Girls' College is a constituent college of Assam University, Silchar which primarily provides regular 19 undergraduate programmes. It also offers a self-financing certificate course and a few institutional certificate courses. Some senior faculties are involved in curriculum planning and development, review of syllabus for UG courses as members of Board of Undergraduate Studies of Assam University.

Since the college is affiliated to Assam University, the curriculum is prepared by the university. For systematic curriculum delivery a Routine Committee is formed at the beginning of the academic session for preparing a time-table for distribution of class hours. The institutional academic calendar committee prepares the academic calendar annually before the commencement of new academic session following the guidelines of the affiliating university and the UGC. It covers the working days of an academic session, schedules of internal assessment and university examinations, academic and co-curricular activities etc.

Teaching plans are drawn out to provide sufficient time for revision, besides completing the curriculum. The progress of curriculum delivery is discussed in departmental meetings and appropriate measures are taken as and when required. The college prospectus works as a guidebook for the students to have an understanding about the working system and the vision, mission and objectives of the college. The college website is another source through which the students acquaint themselves with the curriculum and other relevant information.

The college adheres to the academic calendar for the conduct of Continuous Internal Evaluation (CIE) with a well-structured examination system looking after the internal and external examination and evaluation, following the parent university norms. The college conducts end-semester examinations and other internal assessments, such as assignments, seminar presentations as per the academic calendar. Feedback of the students is collected in each academic session to find out the positive and negative aspects regarding the effectiveness of the curriculum delivery. Parent-teacher's meets should be conducted regularly for more effective curriculum delivery by taking suggestions and other aspects to develop a better environment for curriculum delivery.

Crosscutting issues such as climate change and environmental education are incorporated into the curriculum as Environmental Science is a compulsory subject in the degree level. The contemporary gender issues like discrimination, violence and harassment and such other relevant themes are incorporated in the syllabus. The

staff is guided by the directives of the Assam Government's service rules in the matters of professional ethics. At the Institutional level, a concise document gives details on code of conduct for all the stakeholders, which serves as a manual for day to day transactions ensuring professional and ethical behaviour. The human values of compassion, sympathy and empathy get focused through the community services by NSS/NCC volunteers. During floods, the college opened up its premises to provide shelter for thousands of displaced people with available resources and government aids. The college also rendered humanistic service during covid-19 pandemic.

Qualitative analysis of Criterion 2

As an affiliated college, the college follows the common curriculum, evaluation and assessment procedures designed by the parent University, and keeping in mind the localneeds, the college has adopted different pedagogical approaches to make learning more student centric. The courses require the students to undertake mandatory project work that enhances their knowledge and skill. Student seminars are conducted to help them acquire extensive knowledge of specific topics and also cultivate their communication skills. Guest speakers are regularly invited to provide opportunities to listen and interact with eminent personalities. Through group discussions, seminars and various academic activities, students are given an opportunity to articulate their thoughts on the spot and develop critical thinking and presentation skills. Students are taken for field trips to boost experiential learning. Collaborative learning is ensured through activities under various forums such as National Service Scheme, NCC, Sports, Environmental Cell, Electoral Literacy Club and Red Ribbon Club to foster humanitarian values, networking and team spirit. The students also take active part in several awareness campaigns initiated by the district administration, state government, central government and NGOs.

The campus is Wi-Fi enabled and there are two smart classrooms with overhead projectors, one computer laboratory and ICT enabled auditorium hall. Computer laboratory and mass communication laboratory are utilized to provide hands-on learning experience to the students. The teachers use various ICT tools like power point presentations, spreadsheets and animations for illustrating concepts to the students. Teachers used alternative teaching during the covid-19 pandemic imparting live classes in Zoom, Google Meet etc., lecture videos on YouTube and posting study materials in WhatsApp groups, Google Classroom etc. Teachers now

continue such online teaching blended with classroom teaching.

The Examination Cell formulates the guidelines and routine for the internal examination. Internal assessment outcomes are displayed on the college notice boards and website. This data is sent to the University after students' acknowledgement. The students approach the Examination Cell for grievances. The Examination Cell responds quickly in all such cases in consultation with respective departments to resolve the problem. Absentees are given a chance to reappear in the unit test after due validation of the reasons cited by them. The Examination Cell helps students with their grievances and queries related to results, correction of internal examination marks, project-related works, etc., and other academic matters.

Programme and Course Outcomes are stated and displayed on website and prospectus. To ensure the awareness of Student Learning Outcomes of the programmes and courses, students are provided with the details of their courses of studyat the beginning of each semester so that they can have an understanding of the objectivesof the courses. Hard copies of the syllabi, programme outcomes, Programme specific outcomes and course outcomes are available in the departments for ready reference. The teachers also provide a detailed view of the program specific outcomes and course outcomes of a particular programme of study during the lectures, so the students can decide their choices of optional papers.

The attainment and the level of attainment of POs, PSOs and COs are measured through the performance of the students in the internal assessments, which consist of the sessional examinations, assignments, presentations, etc. The internal assessment and semester end assessment are designed on the basis of programme outcomes, Programme specific outcomes and course outcomes defined for each course. The overall performance reflects the level of attainment of the students. The performance of students in various competitive examinations also acts as a measure of evaluating the attainment of programme outcomes and course outcomes by the students. There needs to be a systematic procedure to measure the attainment of SLOs, POs and COs during each session with proper mapping of the Program Outcomes with the Course Outcomes to assess SLOs i.e. Student Learning Outcome to give emphasis to Outcome Based Education (OBE).

Qualitative analysis of Criterion 3

The college has started to explore the ancient indigenous knowledge of various scientific fields which are naturally imparted in indigenous languages. In order to monitor research activities in the college a Research Development and Journal Cell has been formed. More awareness and activities about IPR, IKS, incubation and innovations are to be brought through various academic and community-oriented initiatives.

The College organizes a few extension activities under the guidance of Cultural cell, NSS and NCC wings along with Youth Red Cross, Women's Cell, Thrift and Credit Cooperative society to promote and sensitize the students towards community needs such asvoluntary blood donation and health checkup camps, outreach campaigns, sensitization and awareness programmes on environment and health related issues. Students visit the adopted village to involve themselves in the field work for community services. The NSS volunteers rendered their services in conducting socio-economic survey on door to door basis, organizing awareness campaign on basic health-hygiene and cleanliness along with literacy awareness programme. The NSS unit of the college also organizes activities on *Swachha Bharat Abhiyaan*, awareness on consumption of tobacco and drug abuse with the sense of social responsibility.

The NSS unit in co-ordination with NCC unit of the college has provided relief materials during flood and covid-19 period to the destitute people with resources provided by college authority. The college took initiative in disseminating the information of COVID-19 protocol in the remote areas when the pandemic broke out. The NSS team conducted a survey work at Dinesh Chandra DevSmriti Children Home, Karnamadhu where 23 children stay under the supervision of the Society

The college is spread over 1.266 acres with 3500 sqmtr of constructed area with 20 Classrooms, two labs, a Mass Communication and a Computer lab with 22 computers, smart classrooms, a central library with a

collection of 19866 books, ICT enabled facilities, departmental libraries, common rooms for faculties and students, a gym, canteen facility with quality food at nominal rates, CCTV surveillance, girls' hostel for 150 students, parking facility, Photocopy shop, NCC Room, Auditorium with 200 capacity, Placement Cell, Counseling Service Cell, two generators with 62.5 KVA capacities etc. Each HOD has a departmental Laptop with Wi-Fi. During pandemic time students'WhatsApp groups were created and online classes were held on Zoom platform, GoogleMeet,Webex etc. The college has sports facilities for basketball, football, badminton, athletics, kho-kho, kabaddi, cricket etc. The Gym is used by students in their scheduled time under the supervision of gym-Instructor. The college is imparting regular yoga training with the help of a yoga instructor.

College library is a well-stocked, air conditioned, ICT and Wi-Fi enabled Central Library spreading over 2500 sq. ft. The library has INFLIBNET subscription of N-list for e-resources. The library has SOUL 2.0 version as the Library Management software for the automation of its routine activities for acquisition, cataloging, and circulation. At present 10000 books are entered in the cataloging module. The OPAC is in use to search the books digitally. Library has sufficient number of reference books and has a special collection of books on 'Kabiguru' RabindraNath Tagore, Barak Valley writers and many rare books on religion and folklore. There are 16 computers with internet facility in library where students prepare their assignments and access online and other electronic e-journals/e-books. The library is partially automated A separate table withlaptops with internet facilities are provided to the faculty members. There is a book bank facility based entirely on donations, including a collection of remedial books for minorities and SC/ST students.

The college has ICT Cell, Website Cell and Digital Learning Cell which meet regularly for the planning and monitoring of the IT facilities in the college. The college regularly updates and provides IT facilities to the students, faculty members and staffs in the college campus. The college has a web administrator who maintains and updates the college website at regular intervals. All the computers in the administrative, academic, library, labs and accounts sections are installed with printer, scanner, and Xeroxfacility. College campus is Wi-Fi enabled to ensure uninterrupted internet with FIBRE PREMIUM PLUS. The college runs a Computer Centre where Certificate courses are conducted.

Qualitative analysis of Criterion 6

The College is regulated by the guidelines of the *Assam Provincialized Colleges and Assam Non-Government Management Rules*, 2001 for policies, administrative setup, appointment and service rules, and procedures. The Governing Body is the highest decision making body and plays a major role in guiding and planning the various strategies for the college. The Principal being the head of the institution, and the DDO (Drawing and Disbursing Officer) is empowered and accountable for all financial and official transactions. The leadership and stakeholders of the institution are conscious of the mission to promote and facilitate female education and strives to integrate its fundamental goals in both short term and long term Institutional Perspective Plans. In anticipation of the NEP and with the aim to adapt and integrate the changes in the near future a few teachers have attended orientation programmes on NEP. The institutional perspective plan is placed in the general meeting of the Teachers' Council to keep updating teaching, learning and evaluation to make it more efficient. The Institution is focused on the use of e-governance and digitalization of academic and administrative processes as all the computers are connected through LAN and Integrated Institutional Management System (IIMS) named Digital Campus System (DCS) are operational.

The College submits Annual Performance Report (APR) for individual teacher to the DHE for promotional considerations to the next grade. The performance of the faculty members is evaluated at regular intervals through feedback system. The Performance appraisal of non-teaching staff is subjected to the rules and guidelines of the Government of Assam. More welfare measures for teaching and non-teaching staff should be taken up apart from what have been provided by the Govt. for their financial security and academic motivation.

The College Development Committee and the Construction Committee conduct meetings to decide on optimal utilization of resources and mobilization of funds. The institute also generates funds from its corpus as a caution to take contingency measures. The college building is used as an examination centrefor various university and Govt. competitive examinations and it is recognized as a Zonal centre for university examinations. The college maintains finance and accounts systematically and conducts internal and external financial audits regularly as per govt. rules.

The IQAC coordinate with all the stakeholders associated with administration, academic affairs and extension activities as per guideline of NAAC in addition regular AQAR submissions. The IQAC should take initiatives for quality assurance, such as introduction of the Teacher's course completion certificate, student mentoring system, Green Audit and introduction of job oriented course to upgrade the quality of teaching-learning process. Another initiative is the feedback mechanism in which feedbacks are collected from students, teachers, alumni and guardians and analyzed for further action. IQAC also conducts External Academic & Administrative Audits to assess the incremental improvements of the college in various activities.

The College takes up contemporary issues like gender, women concerns, safety and security etc. through conducting different awareness programmes. A Women's Cell functions to advocate gender equality with a mission to raise awareness among the college's students and faculty about discrimination based on gender, as well as women's rights, welfare, and empowerment. The whole campus is under CCTV surveillance. Anti-ragging committee has been formed for the purpose of providing safety and security to new students. The college has a Discipline Committee that watches over students during college hours to make sure everyone, especially the girls and ladies, stay safe.

To build national ties and relationships, the institution promotes student involvement in sports and cultural activities, NCC, and NSS. By enrolling students from all sections of the society, the college encourages inclusive environment for everyone with tolerance and harmony. The yearly magazine of the college and the

Wall Magazines of various departments portray the details of cultural, regional, linguistic, communal harmony. Institute has code of ethics for students, teachers and other employees that has to be adhered to maintain discipline irrespective of their cultural, regional, linguistic, communal socioeconomic and other diversities. In order to foster positive connections amongst people from various racial and cultural origins, festivals and commemoration days are observed with fun and fervor. All festivals and observances, such as BhashaSahidDiwas (19 May), Women's Day, International Yoga Day, Rabindra Jayanti, National Youth Day, Sanskrit Diwas, Teachers' Day, Netaji Birthday, Gandhi Jayanti, etc., are celebrated in the college with due importance.

The college helps students applying for and receive scholarships from a variety of sources, including Ishaan Uday, SUHIRD (MLA Scholarship, SC, ST, OBC, Minority, etc. and the college Poor Students' Aid Fund Scholarship, etc. Students in BPL category and with father's annual income Rs. 2 lakh or less is eligible for admission under the Fee Waiver Scheme.

Two best practices are 1. Use of Information and Communication Technology (ICT) in teaching learning process and 2. Career Counselling. Both look an integral part of the education system today which are undertaken by almost all the higher educational institutes to keep pace with the new technology. The college has robust ICT network with ILMS and IIMS in working with LAN and strong Wi-Fi connections.

The distinctiveness of the college is in catering to the needs of economically disadvantaged segments, especiallyEast Pakistan victims of the tragic split of uprooting from their families and faced challenges for a stable financial footing. In order to provide a path to higher education for the girls of these families, the college has been covering over a broad and diversified geographical jurisdiction. Since then, there has been a regular influx of students looking for higher education in and around the town of Karimganj. Today there is healthy representation of students coming from the socially and economically backward sections in the Institution.

Opportunities:

- Job-oriented add-on courses based on the local needs may be introduced to provide the students with more opportunities to equip themselves for better opportunities and support to the locals.
- Linkages and collaborations for placement, research and internship training may provide ample
 opportunities to students of the area to get better placement, more research, and entrepreneurial
 training.
- Establishment of Incubation Centre may boost socially relevant research and innovation.
- Introducing more sports facilities for indoor and outdoor games will tap the local talents in sports.
- More program/course options like PG programs, UG program in Science and more subjects/courses options for BA & B Com can be explored
- There is a need of enhancing student and faculty participation for participative and decentralised governance

Challenges:

- Most of the students are first generation learners from the financially weak section of the remote rural
 areas.
- Due to remote location from industrial area, employability and internship training are real challenges.
- · Resource generation and mobilization for growing needs of the institution and quality initiatives.
- · Commerce stream and Mass Communication Department are yet to be provincialized
- Strengthening community engagement in conducting Govt. socio-economic programmes in the nearby rural areas.
- A well-marked welfare measure for teaching and non-teaching for more academic and financial
 facilities is required apart from what is allotted by the Govt.
